World Heritage UK (WHUK) deeply regrets the decision by the <u>UNESCO World Heritage Committee (WHC)</u> to de-list Liverpool – Maritime Mercantile City from the list of inscribed World Heritage Sites (WHS). We believe this action will be damaging to the credibility of the World Heritage sector in the UK and elsewhere.




### The Slate Landscape of Northwest Wales and the Great Spa Towns of Europe successfully inscribed

The extended 44th session of the UNESCO World Heritage Committee meeting at Fuzhou in the People's Republic of China, 16th-31st July 2021 approved the inscription of two additional World Heritage Sites with UK interests. The Slate Landscape of Northwest Wales and the transnational nomination, The Great Spa Towns of Europe, which includes the City of Bath can now be added to the UK list which now number 34 in the collection. Gough and Inaccessible Islands, The Palace of Westminster and Westminster Abbey including Saint Margaret's Church, Stonehenge, Avebury and Associated Sites and Cornwall and West Devon Mining Landscape World Heritage Sites were also discussed.
