Update from the World Heritage Committee

An Extraordinary meeting of the World Heritage Committee met virtually in Paris on the 2nd November. It decided that the 44th & 45th meetings would be combined in one meeting to be held in person in Fuzhou, China in the last week of June and the first week in July 2021. This will require an extension of the usual 10 days by an additional 2 or 3 days. A virtual option presents many technical problems (190 State Parties, 2500 delegates and managing simultaneous translations). but a plan 'B' will be prepared. There will be a further information session organised before Christmas but the date is not yet known. The 2022 committee is now likely to be held in the Russian Federation and will be the 46th session.



Site Coordinators online forum, 7th December 2020

This year the World Heritage UK Annual General Meeting will be an online event for its Members but will also include updates of value to other interested parties, and will be followed by the 7th UK World Heritage Sites Coordinators online forum.
