Flow Country World Heritage bid enters new phase with submission delivery to UNESCO

entered a new phase with the formal submission of the formal nomination dossier to UNESCO.

A copy of the complete 250-page dossier and accompanying draft management plan, which makes the in-depth case for designating the 190,000-hectare site as the world's first peatland World Heritage Site, was hand-delivered in Westminster by Dr Steven Andrews, the Flow Country Partnership's project coordinator.



and then submitted formally to UNESCO by Laura Davies, the UK's Ambassador to the Paris-based United Nations body. The milestone triggers the next steps in the bid process, which will see inspection visits to the region by UNESCO officials during 2023 enabling a decision on whether to award the accolade of World Heritage Site status taken next year.

If the bid succeeds, the Flow Country UNESCO World Heritage Site will provide a wide range of benefits and ensure the continued protection and conservation of this unique landscape that stores some 400 million tonnes of carbon – more than double the amount stored in all of Britain's woodlands.

It will continue to actively draw down CO2 from the atmosphere for generations to come and create new economic and cultural opportunities for the area's rural communities.

Dr Steven Andrews, who coordinated the preparation of the dossier for the Flow Country Partnership, a collaboration that includes Highland Council, NatureScot, RSPB Scotland, UHI and Wildland Limited said: "A vast amount of work has gone into getting the nomination dossier prepared for delivery to UNESCO in Paris and we are hugely grateful to both the UK Government and also the Scottish Government for the support they have provided in helping us reach this important milestone. We look forward to continuing to work with them, as well as with the communities across the Flow Country, to bring the bid home successfully in the next 18 months."

Lord Parkinson of Whitley Bay, UK Minister for Arts & Heritage, said: "Scotland's stunning and ancient Flow Country landscape offers breath-taking views and is hugely important for protecting against climate change. It would be a worthy recipient of UNESCO World Heritage Site status and the UK Government is

Scotland's Minister for Environment and Land Reform Mairi McAllan commented: "Scotland's peatlands are iconic and an integral part of Scotland's cultural and natural heritage. In good condition, they also play a vital part in our response to the climate and nature emergencies, and our ambitious targets to be net zero by 2045. Peatlands do all of this whilst reducing the risk of flooding and providing a natural filter to improve drinking water quality. That's why the Scottish Government is so passionate about peat and are investing £250 million to restore 250,000 hectares of peatlands over a 10-year period to 2030. The Flow Country achieving UNESCO World Heritage Site status would help give us an international platform to promote the natural beauty of Scotland's landscape - and the importance of restoring and protecting it. And I wish the best of luck to all working on this important bid."

Each year, ICOMOS proposes a **theme for activities to be organised** by its members and partners – and anyone who wants to join in marking the Day.

In keeping with the spirit of open, innovative, constructive intergenerational dialogue, and the strategic focus of ICOMOS <u>Triennial Scientific Plan 2021-2024</u>, as well as the 2020 <u>ICOMOS resolution on Approaches to Cultural Heritage</u>, the 2023 World Heritage Day focuses on:

HERITAGE CHANGES.

World Heritage Day provides a timely opportunity to showcase strategies demonstrating the full potential of heritage research and practices which deliver climate-resilient pathways, while advocating for inclusive transitions to low-carbon futures.

How can traditional knowledge inform innovative and transformative climate action?

- Consider the integration of traditional, historic building conservation, adaptive reuse, and/or energy efficiency of heritage buildings and landscapes
- Feature innovative infrastructure development to showcase the ways in which traditional knowledge, practices and cultural heritage can be part of solutions
- Capture traditional philosophy and rationale in dealing with the environment (both land and water) and the climate as manifested in built vernacular heritage and cultural landscapes

ICOMOS Committees, members and all those wishing to celebrate the IDMS are warmly invited to showcase the myriad ways in which traditional knowledge is/can

The theme of **HERITAGE CHANGES** offers the opportunity to respond to questions regarding learning about traditional ways of knowing and knowledge systems in relation to climate action, and how to use a cultural heritage focus to support equitable protection of vulnerable communities through climate action, while responding to the UN Decade of Action.


Join the conversation to shape what WHYAMs will look like and discover how it can work for your World Heritage Site!

Paul Sandby came to Edinburgh in 1747 as an unknown English draughtsman to draw maps for the military; he left the city 4 years later as a promising artist who would become the so-called father of English Watercolour. During his stay in the city

artist's eye accurately captured a Georgian city on the cusp of changing forever.


