World Heritage UK Autumn Webinar # 2 Gracehill Moravian Church Settlement Wednesday 11th October 2023, 7-8pm, on Zoom

Number 2 in a series of 4 webinar talks, on **the UK's World Heritage Tentative List**, following on from WHUK's successful WH & Nature webinars.

Gracehill Moravian Church Settlement, Northern Ireland

The Moravian Church dates from 1457. In 1722 the Moravians renewed the Church and established a Settlement at Herrnhut in Germany from where they travelled around the world often founding new Settlements wherever they went.

Life in the village nowadays is, of course, very different to the 18th century, but the layout of the buildings and the unique Georgian style of architecture remain very much the same. The village plan is a simple grid pattern with designated green spaces. It is an early example of town planning reflecting the timeless values of education, equality, industry, tolerance, and spirituality that the Moravians shared wherever they established Settlements.

Are you experienced with budgets and finance, and have experience of the heritage sector, and some spare time? If you do, then WHUK could really do with your help. We are seeking a volunteer Treasurer. Sam Rose our current Treasurer is standing down this December. Perhaps you could take this role on?

What we're ideally looking for is:

- Oversee the financial affairs of WHUK, with the assistance of WHUK's Finance Manager, and ensure they are legal, constitutional and within accepted accounting practice

- Be accountable for organisational audit processes, receipts, payments and insurance

- Be responsible for maintaining the WHUK Organisational Risk and Issues Register and Business Continuity Plan

- Monitor and report on the financial health of the organisation to the Trustees, ensuring they are aware of their financial obligations and interpreting financial data where required

- Take the lead on ensuring WHUK's financial probity and transparency

- Oversee and be accountable for the production of necessary financial reports/returns, accounts and audits

- Prepare and deliver the Treasurer's Report to the Annual General Meeting

- Chair the WHUK Risk & Resources Committee

- Liaise with relevant staff, committee members and/or volunteers to ensure the financial viability of the organisation by:

- Overseeing the production of an annual budget and propose its adoption at the last meeting of the previous financial year
- · Appointing and liaising with auditors/an independent examiner
- Ensuring proper records are kept and that effective financial procedures and controls are in place

- Maintain knowledge and experience of current and fundraising finance practice relevant to voluntary and community organisations

A 3-year term of office is considered standard with the option to extend into a second term.

Contested Heritage Guidance

The Department for Culture, Media and Sport has published guidance on addressing contested heritage. This guidance is for use by all custodians of commemorative heritage assets needing advice on how to deal with calls to relocate or remove them from public display.

It applies to any commemorative heritage asset (statue, monument, or commemoration) which is a structure, or is part of a building or structure, which is on public display or in places accessible to the public.

A Heritage Advisory Board was established by the Secretary of State for DCMS to advise on the development of this guidance. Historic England, the government's adviser on the historic environment, was consulted on the preparation of this guidance. It developed a <u>set of case studies</u> to illustrate the variety of ways that reinterpretation has already been put into practice.
