Tickets are £5 each.

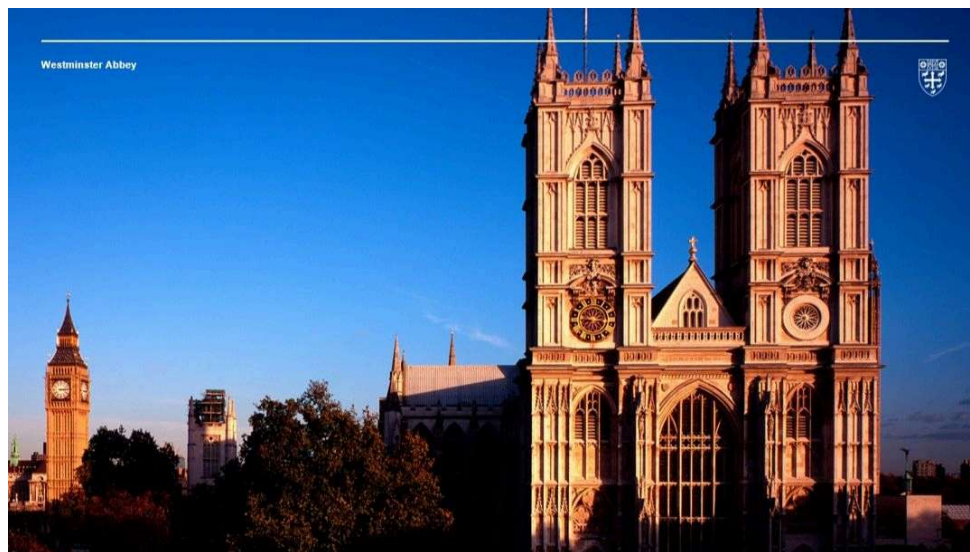
